



Rheem Solar & Tankless Water Heaters that Qualify for the New Federal Economic Stimulus Package Tax Credits

Federal Energy Tax Credits for Rheem Solar and Tankless Water Heaters, February 2009.

The new federal tax credits apply to a selected group of water heaters. Tankless products must be installed in existing homes (primary residence) to qualify. Solar products can be installed in either new construction or existing homes to qualify. **Check with your tax advisor for details.** Only some Energy Star(R) water heaters have been designated for federal tax credits, not all. However, keep in mind that all Energy Star models are highly energy efficient and may be eligible for state and utility incentives and rebates. Stimulus Bill details: Tax credit up to 30% of the cost of <u>equipment and installation</u> . Check with your tax advisor for details. Qualified Dates: Installations from 1/1/2009 through 12/31/2016. Note: No annual tax credit maximums for residential solar equipment and installation			All tankless models above qualify for the new Federal Tax Credits in <u>existing</u> residential construction. Tax credit applies to primary residence only. Stimulus Bill details: Tax credit up to 30% of the cost of <u>equipment and installation</u> . Check with your tax advisor for details. Qualified Dates: Installations from 1/1/2009 through 12/31/2010. The tax credit can be claimed in either year or be split up between the two years. Note: Maximum tax credit cap for each home is \$1500.
