

American Recovery and Reinvestment Act of 2009

Proof of <u>Qualified Energy Property</u> for Claiming Tax Credits for Residential Water Heaters

President Obama signed the American Recovery and Reinvestment Act of 2009 on February 17, 2009, which made important changes to the homeowner tax credits for specified energy-efficient home improvements. These include qualified tankless water heaters (tankless water heaters with an EF rating of 0.82 or better). Two of the more significant revisions to this include the extension of the tax credit through 2010 and the increase of the total available tax credit from 10% to 30%.

Homeowners who purchase a qualified Rheem tankless water heater between January 1, 2009 and December 31, 2010 are eligible for a tax credit equal to 30% of the full purchase and installation price with a cap of \$1,500.00.

The Rheem Water Heating Division of Rheem Sales Company, Inc. certifies that the models listed on the following page of this document (if placed in service between Jan. 1, 2009 and Dec. 31, 2010 in a homeowner's primary residence) meet the criteria of "Qualified Energy Property" as set fourth by Section 25C of the Internal Revenue Code.
