Proof of <u>Qualified Energy Property</u> for Claiming Tax Credits for Residential Water Heaters

Homeowners who purchase a qualified Rheem tankless water heater between January 1, 2011 and December 31, 2011 are eligible for a tax credit equal to 10% of the installed cost, NOT to exceed the cap of \$300.00.

The Rheem Water Heating Division of Rheem Sales Company, Inc. certifies that the models listed on the next page (if placed in service between Jan. 1, 2011 and Dec. 31, 2011 in a homeowner's primary residence) meet the criteria of "Qualified Energy Property" as set fourth by Section 25C of the Internal Revenue Code.
